<b>Additional Information</b>	BILL SUMMARY - As introduced, this bill transfers certain District-owned real property in Ward 8 (Historic Anacostia) to the L'Enfant Trust for renovation and use development as workforce housing. The intended use of the property complies with historic preservation standards. The bill describes the real property as Lot 814 in Square 5779, Lot 849 in Square 5799, Lot 811 in Square 5800, and Lot 884 in Square 5765.
